Terms and conditions

1. The Range Forest Officer shall mark the trees before cutting.
2. Permission to fell trees is granted at his/her risk and without prejudice to claim/s of any other person/s who may be having right/s over the land or trees.
3. Felling of trees shall be completed within **45** days from the above mentioned date.
4. Material produced from the felled trees shall not be removed or disposed without permission of the Tree Officer.
5. He/She shall replant tree as per details given below during ensuing/next planting season, i.e. commencing from June **2021** to August **2022**. Replanting should be done as per the replanting plan submitted by the applicant in Sy. No. 32/9 of Shristhal village Canacona taluka.

6. Licence fee was paid vide R. No. 20/4128 dtd. 29/06/2021 for Rs. 600/- and deposit a sum of **Rs. 3600/- (Rupees three thousand six hundred only)** vide D. D. Conservator of Forests, South Goa Division, Margao-Goa, before starting the felling of the trees for ensuing the replanting of the trees (indicated at Sr. No. 5 above).
