<ol> <li>The Range Forest Officer shall mark trees before cutting.</li> <li>Permission to fell the trees is granted at his/her own risk and without prejudice to the Claim of the Other person who may be having any right over the land or trees.</li> <li>Felling of trees shall be done after 30 days from issue of this permission/ uploading on website and should be completed within 45 days.</li> <li>Material produced from felled trees shall not be removed or disposed without permission of the Tree Officer.</li> <li>He/She shall replant trees as per details given below during the ensuing/next planting season i.e. Commencing from June 2021 in the property from which the trees will be felled.</li> </ol>
