

Open Auction Sale of forest produce at Kurdi Range & Pissonem Range will be held on date, time and place indicated below by the Dy. Conservator of Forests, South Goa Division, Margao Goa.

**Conditions of the Sale**

1. The intending bidder shall have to deposit Rs. 1000/- (Rupees One Thousand only) as E.M.D. before the commencement of the auction. The E.M.D. will be adjusted towards the 25% payment as mentioned in condition 2 for the successful bidder. The E.M.D. of non-successful bidder will be returned after completion of auction.
2. The successful bidder should deposit 25% of the bid amount before the conclusion of the day of auction.
3. The remaining amount of 75% should be paid within 15 days from the date of approval of bid.
4. If the amount is not paid within 30 days from the date of approval of bid and if the goods are not lifted ground rent of Rs. 10/- per m<sup>3</sup> per day will be charged on timber, till the material is lifted.
5. If the material is still not lifted within 45 days (15 days grace period plus 30 days on payment of ground rent) the auction will be set aside and the entire 25% of the bid amount will be forfeited to the Government.
6. The successful bidder shall have to pay GST as applicable.
7. The intending bidder should produce copy of PAN Card before auction.
8. The successful bidder shall have to pay Income Tax towards the purchase of forest produce i.e. timber 2.5% or they should produce a Certificate from the Income Tax Department as prescribed by the Government in Form No.27-C (see Rule 27-C).
9. Decision of the Dy. Conservator of Forests, South Goa Division, Margao will be final in accepting the bid for any lot or dropping out any lot from the sale.
